By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your child’s participation in the Youth & Families for Christ Programs, now or at any time in the future.

Acknowledgment of Risk

I hereby acknowledge and agree that participation in the YFFC 5-day club, YFFC Camp, YFFC Club, YFFC OSS, After-School Drop-in, Community Service, GAPS & any other YFFC activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with YFFC participation, including but in no way limited to: (1) slips, trips, and falls, (2) athletic injuries, and (3) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with YFFC participation and that said list in no way limits the operation of this Agreement.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of my participation in the Youth & Families for Christ Activities , I, _____, the undersigned parent or legal guardian of the youth participant , agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, **HEREBY DO RELEASE** Youth & Families for Christ, its Board, directors, employees, volunteers, agents, representatives and insurers (“Releasees”) from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Youth & Families for Christ on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of the Youth & Families for Christ facilities/equipment or participation in the Youth & Families for Christ programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

Initial

In consideration of my participation in YFFC, I, the parent or guardian undersigned participant, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my Youth & Families for Christ participation.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in general wellness participation and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in YFFC and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death. I further certify that I am in good health and that I have no conditions or impairments which would preclude my safe participation in general wellness.

I further certify that I am the parent or legal guardian of the participant and that I am therefore of lawful age and otherwise legally competent to sign this agreement. I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will.
